Sub: Sensitive handling of issues related to senior citizens and persons with Disabilities

As you are aware, the COVID 19 pandemic has adversely impacted the marginalised sections of society and among them, the Persons with disabilities and senior citizens have been impacted very heavily. In your capacity as District Social Welfare Officer, you are uniquely placed to provide assistance to these sections by making them aware of various Government schemes and programmes. You are directed to handle the issues of persons with disabilities and senior citizens with due care and sensitivity.

In this context, attention of all District Social Welfare Officers is hereby drawn to the order issued from this office dated 21st May 2021, reiterating the orders of Principal Secretary Social Welfare dated 28th March 2020 with regard to designating District Social Welfare officers as district level nodal authorities for taking up the issues of persons with disabilities proactively during the Covid pandemic situation (copy enclosed).

It may also be recalled that the Disability branch has already shared the data of the disability pensioners with all DMs and District Social Welfare officers by mail dated 3<sup>rd</sup> May 2021 (copy of mail enclosed), for reaching out to the PwD population proactively.

Your attention is also drawn to the letter issued by this office, dated 30th May 2021, in which DSWOs were requested to support their WCD counterparts in complying with the directions of the Hon'ble Supreme Court (SMW (C) No.04/2020) by assisting in identifying vulnerable children especially those with special needs, and share information about children who have become orphans post March, 2020 (whether it be due to the pandemic or otherwise) and intimate about them to concerned authorities and also to bring about maximum awareness to the Helpline numbers meant for the vulnerable groups (i.e. Children, Senior Citizens and persons with special needs) for which some IEC materials were also enclosed with the letter. This was shared via mail by Disability branch on date 31/05/2021. (Copy enclosed)

All DSWOs are also aware that exclusive vaccination centres for persons with disabilities one in each revenue district, have been set up on the directions of the State commissioner, Persons with Disabilities. The list of these centres is being enclosed once again. In this context, it may be noted that the Disability branch has already sent the list of NGOs working for persons with disabilities district wise, who can be associated with the work of reaching out to PwDs, via e mail dated 20/5/2021.

All DSWOs have also been circulated the Advisory for Senior Citizens issued by Ministry of Social Justice and Empowerment for information and necessary action of sharing the same with NGOs and Recreation Centres working in your respective districts and also spreading awareness among the senior citizens who are visiting the district offices via mail dated 28 April 2021 (Copy enclosed).

The following points may be noted in this context

- 1. The benefits under social security schemes of the Government may be proactively made available to these sections.
- 2. NGOs working in the district may be associated for reaching out to maximum number of persons with disabilities and senior citizens
- 3. Data shared with Revenue Department about disability pensioners and senior citizen pensioners may be utilised in coordination with Revenue Department staff to reach out to maximum persons in need
- 3. The senior citizen recreation centres located in each revenue district should be utilised to facilitate reaching out to vulnerable senior citizens and assisting them in accessing various facilities.
- 4. Field level functionaries of other Departments such as Anganwari Workers and ASHA workers as well as civil defence volunteers may be roped in through the Revenue Department for identifying needy PwDs and senior citizens and reaching out to them and making them aware about facilities of social security schemes, assistance in filing on line applications for the schemes, awareness building on location of exclusive vaccination centre in the district and other facilities avaiabel to PwDs and senior citizens for sheklter, food, medical aid, counselling and other support services
- 5. The DSWOs are also required to bring about maximum awareness to the Helpline numbers meant for the vulnerable groups.

**Sub:** To share data regarding Children affected by Covid 19 and to popularise the helpline numbers of children and the senior citizens through Resident Welfare Associations in respective districts – reg.

Dear All.

As you are aware the Department of Women & Child Development is the Nodal Department for implementation of Juvenile Justice (Care & Protection of Children) Act, 2015 & Model Rules, 2016. Further, the Department of Social Welfare is the Nodal Dept for senior citizens.

The Covid-19 pandemic has an adverse affect on a larger section of the society and the disadvantaged sections are impacted even more disportionately. The vulnerability is most for children who have been either orphaned or lost one of the parents. Rehabilitation of these children is a major challenge yet it is the primary responsibility of all.

In this context, please take note of orders of Hon'ble Supreme Court (SMW (C) No.04/2020) listed for hearing on 28.05.2021 whereby information about children who have become orphans post March, 2020 (whether it be due to the pandemic or otherwise) has been sought alongwith steps taken for attending to their basic needs. It further stated that the District authorities are directed to upload information of children who have become orphans after March, 2020 on the portal Bal Swaraj (an online tracking portal developed by NCPCR for children in need of care and protection, especially for children in street situations. It is expected that District authorities shall immediately take charge of such children and attend to their basic needs.

In this regard you may take up this matter in the District Task Force and request the SDM (HQ) who is already a member of the said Task Force for building a system whereby no child remains unprotected and in unsafe conditions due to the death of parent/s in the family. Similarly, it is desirable that senior citizens living in the habitat are also taken care of.

Many RWAs have started initiatives for taking care of ration/food/ health needs of such vulnerable sections of society where there is interface between the siad RWA and the family or individual concerned. It is requested to take help of the RWAs for twin objectives - a. Preparing a database of vulnerable children or children in need of care and protection and facilitating them to avail services of the District Child Protection Unit of the respective district or Child Welfare Committee of the said district. The said database be shared with the DTF and also be uploaded on the portal.

It is also suggested that maximum awareness is brought to the Helpline numbers meant for the vulnerable groups ( ie Children, Senior Citizens and persons with special needs) for which we are also sending some IEC materials for ready reference

#### **Advisory for Senior Citizens during COVID-19**

Based on the Census 2011 age-cohort data, it is projected that there would be approximately 16 Crore Senior citizens (aged above 60 yrs) in the Country.

Senior citizens above the age of 60 years face an increased risk in COVID times. This is an advisory for Senior Citizens and their caregivers on how to protect them from increased health risk during this period.

#### For whom is this?

- Aged 60 and above particularly those with following medical conditions
  - Chronic (long-term) respiratory disease, such as asthma, chronic obstructive pulmonary disease (COPD), bronchiectasis, post tuberculous sequelae, interstitial lung disease
  - o Chronic heart disease, such as heart failure
  - Chronic kidney disease
  - o Chronic liver disease, such as alcoholic, and viral hepatitis
  - o Chronic neurologic conditions, such as Parkinson's disease, stroke
  - Diabetes
  - Hypertension
  - Cancer

#### Advisory for Senior Citizens who are mobile:

#### Do's

- Stay within the house all the time
- Avoid having visitors at home
- If meeting is essential, maintain a distance of 1 meter
- If living alone, one can consider depending on healthy neighbours for acquiring essentials for home
- Avoid small and large gatherings at all cost
- Remain actively mobile within the house
- consider doing light exercise and yoga at home
- Maintain hygiene by washing hands. Especially before having meals and after using the washroom. This can be done by washing hands with soap and water for at least 20 seconds
- Clean frequently touched objects such as spectacles
- Sneeze and cough into tissue paper/handkerchief. After coughing or sneezing dispose of the tissue paper in a closed bin/wash your handkerchief and hands
- Ensure proper nutrition through home cooked fresh hot meals, hydrate frequently and take fresh juices to boost immunity
- Take your daily prescribed medicines regularly.
- Monitor your health. If you develop fever, cough and/or breathing difficulty or any other health issue, immediately contact nearest health care facility and follow the medical advice
- Talk to your family members (not staying with you), relatives, friends via call or video conferencing, take help from family members if needed

#### Don'ts

- Come in close contact with someone who is displaying symptoms of coronavirus disease (fever/cough/breathing difficulty).
- Shake hands or hug your friends and near ones
- Go to crowded places like parks, markets and religious places
- Cough or sneeze into your bare hands
- Touch your eyes, face and nose
- self-medicate
- Go to hospital for routine checkup or follow up. As far as possible make teleconsultation with your healthcare provider
- Invite family members and friends at home

Due to Summer, avoid dehydration. Consume an adequate amount of water. (Caution for individuals with pre-existing Heart and Kidney disease)
