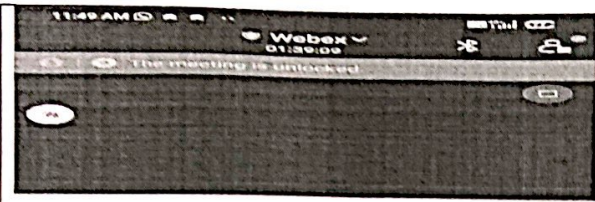


OCEAN GYRES OF THE WORLD



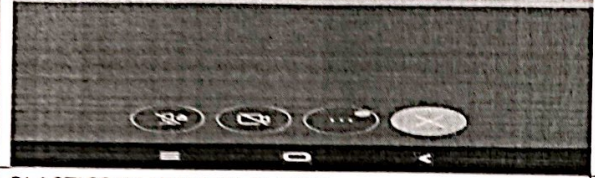
