Subject: regarding re-assessment of the eligibility of the students as per the norms/guidelines of the "Merit-cum-Means Income Linked Financial Assistance Scheme".

Sir/Madam,

The Directorate of Higher Education (DHE) is implementing "Merit-cum-Means Income Linked Financial Assistance Scheme" since 2017-18 to extend financial assistance to the meritorious and needy students pursuing higher education in NCT of Delhi.

And, as per the guidelines of the scheme "Merit-cum-Means Income Linked Financial Assistance Scheme", Concerned Universities/Institutions have been entrusted upon to carry out all due-diligence regarding the eligibility of the students as per the norms/guidelines of the scheme, relevant portion is reproduced as below-

"Administration and Management of the Scheme-

The Scheme shall be administered and managed by the concerned Delhi State Universities/Institutions for themselves and for other Colleges/Institutions affiliated to them. Each of these State University/Institution shall forward list of eligible students in order of merit as per the scheme to DHE, GNCTD. Each University/Institution shall carry out due-diligence and recommend percentage of financial assistance to be granted to each student. It shall be the responsibility of the

ncerned University/Institution to ensure that documentation as per Scheme completed and names are recommended accordingly in order of merit."

All the Universities have forwarded the list of eligible students with the recommendations for financial assistance to Directorate of Higher Education (DHE) for allocation of the funds and a certificate has also been furnished that all the applications have been verified as per the norms/guidelines of the scheme.

However, during the scrutiny of the compiled data and test check of documents of a university, prima facie, following discrepancies have been observed: -

- 1. The name of the student is not found appearing in the NFSS Card family details, in some cases, details of the members of the family not available.
- 2. Mandatory declaration in Format "A" not furnished by the student.
- 3. The Diploma Course students have been recommended while the scheme is for under graduate programme only.
- 4. The Annual Income has been entered as low as Rupee 1. There are a number of such cases.

In view of the above, you are requested to direct the concerned Nodal Officer for examining all the cases meticulously taking into consideration the above-mentioned discrepancies viz. eligibility of the course, income criteria, qualifying aggregate percentage, furnishing of all valid supporting documents, like validity of NFSS Card whether active or inactive, Income certificate, Format "A" and thereafter a certificate in this regard be submitted certifying that all the norms/guidelines regarding eligibility of availing financial assistance in "Merit-cum-Means Income Linked Financial Assistance Scheme" have been followed and forward the list of eligible students for Category-1 in first instance.

This issues with the approval of the Director (Higher Education).
