

Your kind attention is invited to the subject cited above and to inform you that your proposal Id No. EDL03201124012018 for B.A.S.L.P. course has not been considered by the Council based on Joint Assessment Report submitted by the visiting experts as your institute has scored less than minimum score in the following essential parameter 1) Human Resource (56.25%), 2) Clinical Services (30.62%), 3) Clinical Infrastructure (70%), 4) Faculty Development & Research (60%), 5) Curricular Transaction (36.25%) which is less than the prescribed minimum score for granting approval (75% each parameter).
