Candidates have the following option to apply (Online /Offline) for management quota admission for the academic session 2024-25

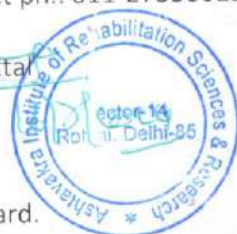
