

It was followed by awareness talk presented by Mrs. Sanjana Mittal in which she expressed her views that Air pollution can be defined as the presence of toxic chemicals or compounds (including those of biological origin) in the air, at levels that pose a health risk. In an even broader sense, air pollution means the presence of chemicals or compounds in the air which are usually not present and which lower the quality of the air or cause detrimental changes to the quality of life (such as the damaging of the ozone layer or causing global warming). She also discussed about some preventive measure to control air pollution like avoiding burning leaves, trash, and other materials, using gas-powered lawn and garden equipment etc. The program proceeded with awareness talk presented by Mrs. Saraswati Sharma in which she discussed the ways to reduce air pollution like turning off the lights when not in use, keeping car, boat, and other engines properly tuned and Conserve energy - at home, at work, everywhere. There after all the students of B.ED.SE ID/HI/VI/LD and ASD one by one depicted the ways to control air pollution through PPTs presentation.
