## यूपी और पंजाब समेत कई राज्यों में बारिश का अलर्ट

नई दिल्ली, एजेंसी। मौसम विभाग ने दिल्ली, उत्तर प्रदेश, उत्तराखंड, पंजाब, हरियाणा, राजस्थान, मध्य प्रदेश, महाराष्ट्र, छत्तीसगढ़, ओडिशा और तेलंगाना समेत कई राज्यों के लिए भारी बारिश का अलर्ट जारी किया है।

विभाग ने मध्य प्रदेश, विदर्भ और छत्तीसगढ़ के लिए अरिज अलर्ट जारी किया है। अगले चार-पांच दिनों में यहां भारी बारिश और तेज हवाओं का सिलसिला जारी रह सकता है। जम्मू, पंजाब, हरियाणा, उत्तराखंड, उत्तर प्रदेश, झारखंड, नागालैंड, मणिपुर, मिजोरम, त्रिपुरा, गुजरात, पूर्वी राजस्थान और मध्य महाराष्ट्र के लिए यलो अलर्ट जारी किया गया है। इन राज्यों में गरज के साथ हल्की से मध्यम बारिश, तेज हवाएं और कहीं-कहीं बिजली गिरने की भी संभावना है।

**पूर्वांतर में सेना ने 3,820 लोगों को बचाया:** पूर्वांतर के कई राज्यों में भारी बारिश और बाढ़ के मद्देनजर सेना ने राहत अभियान शुरू किया है। सेना ने 40 राहत टुकड़ियां तैनात की हैं और कुल 3,820 लोगों को बचाया है।

## निवेशकों के करोड़ों हड़पने वाला पंजाब में गिरफ्तार

लखनऊ, विशेष संवाददाता। यूपी पुलिस ने अब आर्थिक अपराधियों पर भी शिकंजा कसना शुरू कर दिया है। इसी कड़ी में ईओडब्ल्यू ने उत्तर प्रदेश समेत 10 से अधिक राज्यों में निवेशकों का 49 हजार करोड़ रुपये की ठगी के आरोपी गुरनाम सिंह को पंजाब के रोपड़ से गिरफ्तार कर लिया।

गुरनाम ने अपनी कम्पनी प्लस एप्रोटेक कॉर्पोरेशन लिमिटेड (पीएसीएल) के जरिए हजारों करोड़ रुपये निवेशकों का हड़प कर फटार हो गया था। उसे इससे पहले सीबीआई भी गिरफ्तार कर चुकी है। वह जमानत पर बाहर था। ईओडब्ल्यू उसे सात साल से जालीन में दर्ज ठगी के मामले में तलाश कर रही थी। ईओडब्ल्यू ने एक अन्य मामले में 250 करोड़ के घोटाले के एक अन्य आरोपी प्रेम प्रकाश सिंह को कोलकाता से भी गिरफ्तार किया है। ईओडब्ल्यू की डीजी नीरा रावत के मुताबिक यह अब तक का सबसे बड़ा आर्थिक घोटाला है। उसने करीब पांच करोड़ लोगों को ठगा था। इसमें सीबीआई चार आरोपितों को पहले ही गिरफ्तार कर चुकी है। गुरनाम पीएसीएल कम्पनी के निदेशकों में शामिल था। उसकी वर्ष 2018 से ईओडब्ल्यू तलाश कर रही थी। डीजी ने बताया कि पीएसीएल ने 10 प्रदेशों के निवेशकों को लुभावनी योजनाओं और बड़ा रिटर्न मिलने का लालच देकर 49 हजार करोड़ जमा करा लिए थे।

## विदेश से ठगी करने वाले गिरोह का भंडाफोड़ किया

सहारनपुर, वरिष्ठ संवाददाता। विदेश में बैठकर धोखाधड़ी से जारी कराए गए भारतीय मोबाइल फोन नंबरों से ठगी करने वाले अंतरराष्ट्रीय गिरोह का भंडाफोड़ हुआ है। आरोपी व्हाट्सएप के माध्यम से कई देशों के लोगों से करोड़ों रुपये की ठगी कर चुके हैं। गिरोह में शामिल सरगना सहित दो आरोपी पहले से ही जेल में बंद हैं।
